Boarding Agreement & Medical Authorization

1. Ownership & Health Requirements

I certify that I am the legal owner or authorized guardian of my dog(s). My dog(s) is current on Rabies, Distemper, and Bordetella vaccinations, free of fleas, ticks, lice, and contagious illness, has not shown signs of illness within the past 30 days, and will wear a properly fitted safety collar while boarding.

2. Health Risks & Group Play

I understand that boarding and group play involve inherent risks. Vaccinations reduce, but do not eliminate, the risk of illness. Despite reasonable supervision, injuries such as bites, scratches, punctures, sprains, or abrasions may occur.

3. Behavior & Participation

I certify that my dog has not displayed dangerous or aggressive behavior toward people or other animals. Every Doggie Has Its Daycare & Boarding reserves the right to remove my dog from group play, separate my dog, or discontinue services if my dog's behavior is considered unsafe or inappropriate.

4. Medical Emergencies

In the event of a medical emergency, I authorize Every Doggie Has Its Daycare to obtain immediate veterinary care if I or my emergency contact cannot be reached. Any end-of-life instructions I have provided, including a Do Not Resuscitate (DNR) request, will be shared with the attending veterinarian whenever reasonably possible. All medical decisions, including resuscitation or euthanasia, will be made solely by the licensed veterinarian based on their professional medical judgment and applicable Arizona Law. I understand that Every Doggie Has Its Daycare and staff cannot make these medical decisions. I accept full financial responsibility for all veterinary expenses incurred.

5. Release of Liability

6. Boarding Policies

Boarding is charged in 24-hour increments beginning at check-in. Early pick-up does not qualify for refunds or credits. Pick-ups beyond 24 hours may incur daycare charges. Holiday reservations require a two-night minimum stay and deposit. Deposits are refundable only if canceled at least seven (7) days before arrival. No refunds are issued for late cancellations, no-shows, or early departures. If my dog is not picked up as scheduled, I authorize continued boarding or daycare at my expense.
